Terms and Conditions for Enrollment in this Public Tuition Program:

1. The following details the terms and conditions per learner enrolled **per subject**.
2. Classes are charged at a nominal fee of R 120 per lesson (debit order/early EFT), R 125 per lesson (EFT), R135 per lesson (cash packages). Learners are billed once registered for their programs, and are expected to attend the program regularly. Thus it is not possible to pay per lesson.
3. Learners may trial the first two sessions subject to paying the applicable registration fee.
4. A registration of R 475 is applicable for all new learners in grade 10-12.
5. Returning learners pay a registration fee of R 375.
6. Failure to attend 4 or more sessions may lead to a learner's dismissal from the program.
7. Fees are payable in advanced either via EFT / Debit Order / Cash according to the following table. This is applicable for learner joining from the start of the program or during the first two sessions. Adjusted quotes must be requested for learners joining later.

8. Learner's who join after the start of the program will receive a customized bill that considers the appropriate lesson charge, registration fees and their method of payment.
9. Cancellation: In the event that a learner cancels registration, 4 lessons notice must be given. The learner will be entitled to attend sessions for the 4 sessions since the notice was received and will be billed until the last session attend (i.e. the 4th session since the notice was received).
10. Since the program is based on an installment plan, fees may be due to YaleSA or the client when the cancellation is received. If fees are due to the client, we will refund the client. If fees are due to the Academy, this will be deducted as the final payment. Note that this require manual reconciliation as some months have more sessions than others.
11. It is important to understand that payment is based on an installment plan, rather than a monthly charge in order to make administrative matters easier.
12. Learner's will not be admitted to classes if fees are not up to date and all paperwork completed.
13. This program does not include the NBT preparation sessions which are billed separately.
14. This program does not include unlimited access to the YaleSA study hub.
15. The account payer consents to a credit and affordability assessment.
